What is Title I, Part A?

Title I, Part A is part of the Elementary and Secondary Education Act passed in 1965. This act was amended by the Every Student Succeeds Act (ESSA) in 2015. ESSA provides federal funding to Local Education Agencies (LEAs) with high numbers of students living in poverty. The purpose of this funding is to assist students in obtaining proficiency on state academic content and student achievement standards. Title I, Part A should enhance teaching and learning, support local reform, include strategies for parent involvement, and utilize evidence-based strategies.





Ensuring equitable opportunities for all students

Robert J. Burch Elementary School operates a **schoolwide** educational program. This means that while Title I schools / students are identified using a poverty qualifier, all Burch students regardless of family income can benefit from Title I services.

Schoolwide Program Schools

- All students may participate in Title 1 funded activities
- Maximizes flexibility in using federal funds
- Serves as a vehicle for whole-school reform with focus on improving the achievement of the lowest achieving students
- Addresses students' needs through a schoolwide plan based on a comprehensive needs assessment

Continuous Cycle of Improvement

Planning for Title I follows the Georgia Department of Education Continuous Cycle of Improvement



- 1. Identify needs Each Spring, staff & stakeholders work through the Comprehensive Needs Assessment process by analyzing achievement, process, and climate data and responding to criteria in each of the 5 CNA areas to determine the school's strengths and growth areas
- 2. Selecting interventions Needs and goals are identified then interventions are selected to address these
- 3. Plan implementation and action steps *The implementation plan is created, including action steps, resource needs, and timelines*
- 4. Implement plan Ongoing throughout the school year
- 5. Examine progress Regular data and implementation checks and adjustments to plan

Remember, Title I Part A is a supplemental educational program designed to improve student academic outcomes.





GMAS 5 Year ELA Proficiency - All Students




GMAS ELA 3 YR Comparison, ED, SWD, ELL





GMAS Math 3 YR Comparison, ED, SWD, ELL






21-22 2nd-5th End of Year Reading Inventory



22-23 2nd - 5th Beg. of Year Reading Inventory



21-22 Burch STAR Math End of Year 70th Percentile Proficiency




State's grades report for Robert J. Burch Elementary

Performance Snapshot - Score B 83.6

- Robert J. Burch Elementary School's overall performance is higher than 78% of schools in the state and is lower than its district.

 93% of schools in the state and higher than its district.
- 60.0% of its 3rd grade students are reading at or above the grade level target.

Parents Right to Know

In compliance with the requirements of the Every Student Succeeds Act, parents may request the following information:

- Whether the student's teacher-
 - has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction;
 - is teaching under emergency or other provisional status through which state qualification or licensing criteria have been waived; and
 - is teaching in the field of discipline of the certification of the teacher.
- 2. Whether the child is provided services by paraprofessionals and, if so, their qualifications.
 - All FCPS teachers and paraprofessionals are certified by the Georgia Professional Standards
 Commission and each day our staff works to engage, challenge and support all students to
 achieve at high levels
