## Title 1 Part A



Title 1 Part A funds provide supplemental funding to support educators in improving the academic achievement of students who are economically and educationally disadvantaged.

Title 1 Funding Requirements: If at least 40% of students qualify for free or reduced lunch

BMMS operates a Schoolwide Educational Program. All students, regardless of family income benefit from Title 1 services

## School Improvement Plan

Increase student growth by 3% on the Georgia Milestones

Reduce student discipline referrals by 10%

Title 1 Teachers - grow students scoring below grade level by 1.5 grade equivalent years in ELA & Math

## Action Steps (Increase Student Growth)



1) Provide students with opportunities for remediation and enrichment during the school day.

2) Core content teachers will collaborate through PLC to discuss the progress of student achievement and growth.

3) The RTI Specialist will analyze student performance data to inform instructional practices and collaborate with teachers to facilitate the delivery of appropriate interventions that support the achievement of struggling students.

4) Teachers will continue to utilize technology to monitor student growth and enhance instructional strategies and increase student engagement.

5) Provide professional learning to staff to cultivate and model effective and research-based instructional best practices.

6) Teachers will collaborate with Title 1 teachers/certified professionals/RTI specialist to deliver differentiated instruction and flexible grouping to support student growth and achievement.

7) The Student and Parent Support Teacher will provide parent workshops and family engagement opportunities outside of school hours to address student needs and communicate grade-level and content-specific best practices.

8) The Student and Parent Support Teacher will work with teachers to gather input from parents and students to establish individual student achievement goals for the school compact.

Action Steps (Reduce Referrals)

BENNETT'S MILLI

1) Deliver, reteach and model PBIS lessons based upon discipline data with a consistent approach with an emphasis on the appropriate use of technology among students.

2) Implement a token economy consistently and pervasively to reinforce positive behavior and engagement.


 Provide opportunities for struggling teachers to have PL, mentor, or observe others to strengthen classroom management to make a positive impact on school culture.




#### 6th Grade - Reading Plus Benchmark 1




#### 7th Grade - Reading Plus Benchmark 1




#### 8th Grade - Reading Plus Benchmark 1




#### 6th Grade - Star Math Benchmark 1
