We are excited to inform you that your student is eligible to participate in our after school programs at Flat Rock Middle School. As a Title I school, we receive funds that allow us to provide additional support to our students in writing, math, reading, social studies, and science from 3:30 P.M. to 5:00 P.M. on Tuesdays. Students have been selected based on a variety of criteria including end of the year grades, Georgia Milestones scores, and teacher recommendations. Some students have been invited to attend on multiple days.

Your child has the opportunity to participate in this exciting initiative. He/she has been identified as needing additional support in one of the content areas listed above.

The purpose of the FRMS Title I Extended Day Program is to reinforce learning and provide extra academic support for your child. The program begins **January 29, 2019**, and concludes on **March 26, 2019**. This will allow many extra hours to provide support to your child prior to the spring GA Milestones assessment. We are thrilled to have the opportunity to work with you and your child toward meeting and exceeding the standards.
