FINAL EXAMS

Senior Final exams are scheduled for Friday, May 21 and Monday, May 24. For Friday, May 21, the Senior exam schedule is 4th, 5th, 6th and 7th period exams during their regular assigned period. For Monday, May 24, the Senior exam schedule is 1st, 2nd and 3rd period exams during their regular assigned period.

Underclassmen Final exams are scheduled for Tuesday, May 25 - Friday, May 28. The final exam schedule is as follows:

Tuesday May 25 - 1st and 2nd period exams/3rd and 4th period Study Sessions Wednesday May 26 - 3rd and 4th period exams/5th and 6th period Study Sessions Thursday May 27 - 5th and 6th period exams/7th Period Study Session

Friday May 28 - 7th period exams

EXAM EXEMPTIONS

Notification of exam exemption eligibility will be on Wednesday, May 12 at 8:00 a.m. and end on Thursday, May 13 at 4:00 p.m.. Your teachers will discuss with you if you are eligible to exempt an exam in their class based on the exam exemption criteria. There are three types of exam exemptions: Senior(Junior Marshal) for S2 only, General and Academic. A student can only choose one type of exemption: Senior, General or Academic. Exam exemptions cannot be mixed. Note - Courses that complete an EOC are exempted from a second semester final exam and courses that complete an AP exam are exempted from a second semester exam.

General information regarding exam exemptions is as follows:

Senior exemptions(S2 only):

- To be eligible for a Senior exemption, Seniors(Junior Marshals)may exempt all second semester exams provided the student has an 80% in the class he/she is planning to exempt.
- Students who do not qualify for senior exemption may still use a GENERAL or ACADEMIC exemption. Please follow the criteria for underclassmen exam exemptions.

General exam exemption:

- To be eligible for a General exam exemption, a student must have an overall grade of 70 or higher on notification day.
- A student may exempt **ONE** exam using a General exam exemption.

Academic exam exemption:

- To be eligible for an Academic exam exemption, a student must have an overall grade of 95 or higher in a given class.
- If you are enrolled in seven classes, including those classes at FCHS, COI and/or Work-based learning, then he/she may choose to exempt up to **THREE** final exams.
- If a student is enrolled in six(or fewer) classes at FCHS because he/she a DE "travel" period or 1st or 7th period OPT OUT, then he/she may choose to exempt up to **TWO** final exams.

PARENT EXAM EXEMPTION FORM

For underclassmen, when entering exam exemptions are completed by your teachers, a notification will be sent on Friday, May 14 by 4:00 p.m. for you and your parent/guardian to view the exam exemptions selected in Infinite Campus. There will be a tab titled "S2 Exam Exempt". In this tab, it will list your exam exemptions that you selected for the second semester. Please review your selected exam exemptions. In this notification, there will be a form for parents to complete regarding Check-in, Check-out and leave after the second final exam during Final exam week. In order for a student to Check-in, Check-out or leave after the second final exam, this form must be completed and/or a parent note must be given to allow Check-in, Check-out or leave after the second exam. Parents must have an active parent portal in Infinite Campus to receive the form.
