WHS Exam Exemption Policy:

<u>Academic Exemption</u> – Students may elect to exempt up to **three final exams** with academic exemption, if they have a 95% or higher in the class.

Students who opted out of the 7 period day may elect to exempt up to **two final exams** with academic exemption, if they have a 95% or higher in the class.

<u>Attendance Exemption -</u> Students may elect to exempt **one final exam**, if they have a 73% or higher and no more than five attendance events during the first semester.

Note: A student may only choose one exemption option – academic **OR** attendance.
