### What is an ESPLOST?

 This is NOT a new tax. Continuation of ESPLOST II that will expire in March 2019

 1% sales tax, for the next five years, on goods and services purchased in Fayette County specifically to support our excellent public schools.

 Must be used on hard assets such as buildings, books, buses and computers. Cannot be used for salaries or other operating costs.

## We currently **<u>HAVE</u>** an ESPLOST

Visitors shopping or dining in Fayette County support our schools. We estimate this to be approximately 30% of collections.

If you spend money in another metro Atlanta County, you pay an ESPLOST that supports that school system:

- Atlanta Hartsfield Airport Clayton County Schools
- Ashley Park Coweta County Schools
- Mercedes Benz Stadium Atlanta Schools
- SunTrust Park Cobb County Schools


### What Projects Have Been Completed with ESPLOST?

- Secured the entrances of all schools with access control and cameras.
- Equipped every classroom in the county with the "Classroom of Tomorrow" technology.
- Provided for the connection of the two halves of McIntosh High School.
- Paid down over \$25M in bond debt.
  (Annual bond service has gone down \$5M a year.)
- Build the addition of an auditorium for Fayette County High School (in progress).

#### Invest in One-to-One Computer to Student

- ✓ How it works
  - ✓ Student would take home computer on loan, like a text book
  - ✓ All books would eventually be "e-books" reducing costs over time
- Results expected
  - ✓ Greater student/ teacher interaction through virtual classroom
  - Technological savvy required for college and now basic job skill
  - ✓ Many systems including Coweta have already adopted this standard
- Invest in Connected Classroom II
  - ✓ Builds on Classroom of Tomorrow in ESPLOST 1.0 (2008)
  - Expands connectivity pipe to facilitate online access


Fayette County's public schools routinely perform at the top echelon of Georgia's school systems regardless of measure.

## **Funding Public Education**


- 1. State Funds provided under "QBE"
  - State legislature has underfunded the State Constitution formula for QBE (Quality Basic Education) since before the recession. To date, the cuts have cost our schools almost \$109M.
  - The legislature assumes "everyone has an ESPLOST" to offset these cuts
  - The state contributes 48% of Fayette's education budget, versus the statewide average of 53%.



- 2. Federal Funds
  - These funds are mostly tied to anti-poverty programs such as Title I. Fayette receives about 3% of it's funding through Federal sources, versus the statewide average of over 6%.

## **Funding Public Education**

- 3. Local Property Taxes
  - Fayette County pays 19.5 Mils, down from 20 Mils (the maximum millage rate).
- 4. ESPLOST
  - ✓ 158 counties out of 159 Georgia's counties use ESPLOST.
  - While Fayette is considering ESPLOST 3.0, many counties, including Coweta County, are on their 4<sup>th</sup> ESPLOST.
