- [4] Electro Painting and Refurbishing Inc: Did not submit a completed and notarized Business Capability
- [5] New World Restoration LLC: Submitted a Business Capability Form with a forged notary stamp.
- [6] J&B Painting and Construction LLC: Submitted a completed Business Capability Form unnotarized.
- [7] American Office Services Inc: Submitted a completed Business Capability Form unnotarized.
- [8] Electro Painting and Refurbishing Inc: Did not submit a completed Cost Proposal, as required. Standard quote was submitted for this project.
- [9] Electro Painting and Refurbishing Inc: Did not submit W-9, as required.
- [10] New World Restoration LLC: Did not submit a W-9 Form, as required.
- [11] Electro Painting and Refurbishing Inc: Did not submit a current Certificate of Insurance, as required.
- [12] New World Restoration LLC: Did not submit a current Certificate of Insurance, as required.
- [13] J&B Painting and Construction LLC: Submitted several insurance documents but most items were not in Certificate of Insurance format. Certificate of Insurance for Automobile Liability was submitted but did not list Fayette County Public Schools as the Certificate Holder which is required.
- [14] Electro Painting and Refurbishing Inc: Did not submit completed and notarized E-Verify Documents, as required.
- [15] New World Restoration LLC: Submitted E-Verify Documents that had forged notary stamp.
- [16] New World Restoration LLC: Paperwork was out of order.
- [17] American Office Services Inc: Paperwork was out of order.
- [18] Electro Painting and Refurbishing Inc: Did not include pricing for the interior of the lockers, which was specified in Addendum 1 for this solicitation.
- [19] Electro Painting and Refurbishing Inc: Due to the lack of paperwork submitted, vendor has been deemed Non-Responsive.

[20] New World Restoration LLC: Due to the forged documents and the lack of overall paperwork, vendor has been deemed Non-Responsive.
